- Share this policy, the occupational health and safety plan, the code of ethics and all other relevant documents relating to the management systems with the company's stakeholders, in addition to taking steps to ensure these are complied with.
- Oversee the implementation of this policy and ensure it is rigorously complied with, protecting Ayesa's image and that of its stakeholders, in accordance with its corporate code of ethics.
- Provide the tools, and technical and human resources necessary for achieving the above.
